Guidelines for authors

Historical Social Research - Historische Sozialforschung (HSR) is an international bilingual journal for the application of formal methods to history and was founded in 1976. The application of formal methods to history covers from quantitative and computer-assisted qualitative social research, historical sociology and social scientific history up to cliometrical research and historical information science. In a broader sense the field *Historical Social Research* can be described as an inter-/ transdisciplinary paradigm. Four HSR-issues plus one supplement are published every year.

Historical Social Research - Historische Sozialforschung (HSR) is a bilingual journal (English and German), but substantial articles should be in English language to foster international communication. HSR is accepting manuscripts for reviewing and publication only under the condition that the manuscripts have not been published elsewhere and are not submitted to other journals simultaneously. The manuscripts should be submitted by e-mail to hsr@gesis.org.

Guidelines for manuscripts

Scripts are welcome – both in German and English language. Please, hand in your contribution as word-file and as printed original for controlling with preferably little own formatting.

- **Author:** Every article has the author's complete address of communication attached.
- **Abstract:** Articles longer than six pages are to be prefaced by an English abstract outlining shortly the article's content and composition. The abstract's length should not exceed 150 words. If possible please provide a German version of the abstract.
- **Formatting:** The continuous text should be in 9.5 point Times (or Times New Roman) with the exact line pitch of 11.5 pt. Footnotes should be in 8 point Times (or Times New Roman).
- **Keywords:** Articles longer than six pages have English keywords and – if possible – German keywords.
- **Language:** German or English
- **Tables and graphics:** When compiling tables and graphics it should be considered that the type area is 10,7 cm (width) x 17,1 cm (height). Tables and graphics are to be submitted in black-and-white-quality. Graphics are to be provided as tiff files, the resolution must be at least 300 dpi.
- **Bibliographical references:** Due to the coverage of all HSR articles in the Social Science Citation Index (Thomson Scientific), JSTOR (ITHAKA), SCOPUS (Elsevier) and SocINDEX (EBSCO) a consistent citation and reference is necessary. The bibliographical references at the end of the text and the in-text citations should follow the Chicago Citation Style and are to be compiled as follows:

Author rights

Due to the complex international legal situation and the associated legal and administrative efforts no explicit editorial contracts are made with the authors – which is also eased by the fact that neither the authors nor the individual editors are paid by the publishing house GESIS/HSR. As it is common in many international journals, the authors receive before delivering their article in the “information for the authors” a note to the “copyright” which settles the relationship between the publishing house and the author.

1. Upon submitting a contribution, the HSR editors have the right, after a successful peer review, to publish it. After the contribution appears in HSR, it is still possible to publish it elsewhere after the consent of the HSR editors and with reference to the place of the first publication.
2. The contributions submitted should be original ones. They should not have been published or submitted for publishing at any other point in time in a similar form or with generally the same content.
3. It is the responsibility of the author, not of HSR, to obtain permission to use any previously published and/or copyrighted material (e.g. photos).
4. The special editors receive as a service of the GESIS/HSR a certain amount of free copies of the entire HSR (at the moment authors can receive 5 to 10 free copies; and special editors up to 40 free copies) as well as the PDF-file of the particular article (by author) or the entire HSR Special Issue (editors) for private and academic use.
5. Reprints of contributions already published elsewhere are only accepted if (a) it appeals to the interests of the HSR readers and it has not already reached a wide audience and if (b) it is assured that the copyright owner allows the reprint (in the case the submitting person is not the copyright owner). If these conditions are fulfilled, HSR may accept reprints, which will be published with reference to the place of the first publication.
6. HSR has the right to publish any contribution e.g. on CD-ROM or for selected print editions at any time in the future. In that case, the respective authors will be informed. Authors will also be notified, if other publishers ask for reprints of contributions, originally published in HSR.
7. HSR has also the right to provide the articles for the informational coverage and digital archiving in the INTERNET by the corresponding information- and documentation services and online data bases (HSR-RETRO, JSTOR, Socindex-With-Full-Text, SSOAR etc.) and it can transfer a limited user right to these service providers for each document. The authors and individual editors are to be informed about the legal situation already at the beginning of their production process.
