

Ad Hoc module Interim Report - 2007

LFS Ad hoc module on Accidents at Work and Workrelated Health Problems

The purpose of this report is to provide a brief description of work which has been carried so far in connection with the implementation of Commission Regulation 341/2006 on Accidents at Work and Work-related Health Problems.

1.0 General Description

1.1 General Characteristics

This Office plans to carry out the ad hoc module during the second quarter of 2007 and all questions are intended to be incorporated within the core questionnaire of the LFS 2007. The survey will be carried out amongst a sample of private households, including people who are temporarily absent from their usual residence. Within the LFS a household is defined as one or more persons who live together and share expenses. A person who is abroad during the reference week and who visits Malta on a regular basis, i.e. at least twice a year, is considered to be part of the household. Children or any other members who are living in another dwelling or institution are excluded.

1.2 Weighting and Questionnaire design

Specific weights will be computed for the ad-hoc module sample.

Ad module data will be collected using paper questionnaires. In view of this the module questions will be integrated in the questionnaire together with the core variables. Filters will be applied in the questionnaire so that ad hoc module questions are only addressed to the target population.

2.0 National questionnaire and filters

This part of report will provide the list and sequence of questions which will be included in the ad hoc module. Filters for the various questions are also included. Reference is being made to the EC Regulation column.

Harassment and bullying refer to intentional use of power against another person or group that can result in harm to physical, mental, spiritual, moral or social development (psychological violence is to be included in 11B).
