- Box 5 – "shorter than 1 year": The exact number of months between 1 and 11 should be written (codes: 1-11)
- Box 5a – "1 year or longer": The exact number of years within the range 01-96 (code 01-96) should be inserted or "since birth" (code 00)

^{d)} Question: How long is a person planning to stay in Poland?: The exact number of months between 1 and 11 should be written (codes: 1-11), or 1 year or longer (code 12), or if a person terminates his/her stay in Poland in the surveyed month - 0 (code 0)

^{e)} If it is shorter than 12 months – the exact number of months; 1 year or longer – code 12. If overall: actual and planned duration of stay in Poland < 12 months – person does not qualify for the survey.

^{f)} Question: How long is a person absent from the household? (actual absence) The exact number of months between 1-11 should be written (codes: 1-11), or "1 year or longer" (code 12).

^{g)} Question: How long is the person going to be absent from the household? (planned absence): The exact number of months between 1-11 should be written (codes: 1-11), or "1 year or longer" (code 12), or if a person is coming back to the household in the surveyed month – "0" (code 0).
